East Lyme has a draft agreement for the maintenance of the pump station by their own employees. We are waiting on the agreement from East Lyme's attorney to be part of the system for the conveyance fee.

EIE (Environmental Impact Evaluation): This has been seen by the Department of Public Health and has been reviewed and signed by Betsy Winfield and Denise Ruzicka from the DEEP. It will now be going to the Department of Policy Management for their review.
