GUEST: Steve Flanagan from Flanagan Associates, Waterford Ct. was here to discuss different options for charging for the EDU's. He listened to our concerns and what we are looking for in an appraisal. He is willing to work on an appraisal for a deposit of \$5,000.00. We will get back to him at a later date with our decision.

WATERFORD UPDATE: They originally wanted a \$168,000 buy-in fee. The attorney's for Waterford, East Lyme and OCBCA have met. We are waiting to hear back from them and from the town of Waterford.

LAND LEASE SITES: The 78 Portland Avenue site is a possible site for our pump station. The land is privately owned by Scott Booulanger and he is going to see if he can get approval for us to use it for the pump station. It would be \$50,000 with a 99 year lease.

CLEAN WATER FUND APPLICATION: We submitted our application and we are in the process for the funding of the force main and pump station, Phase I.

DEEP wants all 3 parties, Old Lyme Shores, Miami Beach and Old Colony Beach to be responsible for the debt but and 1 entity for billing and monitoring it. Old Colony Beach we be the liaison.

OTHER BUSINESS: none at this time.
