WPCA AUGUST 17, 2020

CALL TO ORDER: The meeting was called to order at 6:45 pm by Frank Noe, Chairman.

PRESENT: Frank Noe, Bob Asal, Don Brodeur, Joe Cancelliere, Nancy Zimmerman. Steve Humes called in by phone.

GUEST: Doug Whalen, OCBCA Chairman

ABSENT: Frank Nicotera

APPROVAL OF THE JULY 13, 2020 minutes: A motion was made by Bob Asal and 2nd by Joe Cancelliere to approve the minutes. No discussion, none opposed, motion passed.

TREASURER'S REPORT: Don Brodeur reported that as of July 13, 2020, the checking account balance was \$48,804.40. We had a bank transfer from Tri-Beach Share Account for \$29,619.07 that gave us a balance of \$75,423.47. We had a disbursement to Fuss & O'Neill for \$29,619.07 and a disbursement to the US Postal Service for \$56.00 that left a balance of \$45,748.40.

The Tri-Beach Infrastructure Share Account had a balance as of July 13, 2020 of \$4,975.01. We had a deposit for the State of Connecticut for \$29,619.07 which gave a balance of \$34,594.08.

We had disbursements to the Town of Old Lyme for the IWWC (Inland Wetlands & Watercourses Commission) for \$75.00, another to the Town of Old Lyme for OCBCA CT DEEP for \$60.00, another bank transfer to WPCA For \$29,619.07 and the last one to the attorney, Brendan Sharkey for \$687.50, leaving a balance as of August 17, 2020 of \$4,152.51.

A motion was made by Bob Asal and 2nd by Don Brodeur to accept the treasurer's report. No discussion, none opposed, motion passed. OTHER BUSINESS: Amtrak has approved the bridge for putting the pipe through the girders and now it will go to the DOT for their approval.

OLD COLONY BEACH CLUB ASSOCIATION Water Pollution Control Authority

The lateral forms regarding where homeowners want the pipe to be placed for the sewers need to be returned to Fuss & O'Neill, so Frank will have some of the members take each street and ask them to please send in their form ASAP. Homeowners can contact 2 different people at Fuss & O'Neill if they need help filling out the form and then e-mailing it back to them. WELLS: There are 16 wells that are within 25' of the sewer line, of which 10 are currently connected to CT Water, which leaves 6 that are not connected to CT Water. They can keep their wells, but for irrigation purposes only. The other 6 must be abandoned. The wells that are within 75' of the sewer line, 9 of them are connected to CT Water.

PROPERTY ON PORTLAND AVENUE: A motion was made by Steve Humes and 2nd by Bob Asal to purchase the property for the pump station, with the other beaches, from Scott Bulanger for \$50,000.00 with the provision that his family can use the property for parking their cars as long as their parking doesn't interfere with our pump station and a limit of 4 cars.

PUBLIC COMMENT: Doug mentioned that a homeowner has brought up some concerns regarding the sewers and the road paving. These concerns are being handled by Frank Noe.

NEXT MEETING: The next meeting will be on September 21, 2020 at 6:30 pm and will be a ZOOM meeting.

MOTION TO ADJOURN: A motion to adjourn was made by Joe Cancelliere and 2nd by Nancy Zimmerman. The meeting adjourned at 7:30 pm.
